Release of Liability

Waiver of Claims and Indemnity Agreement

This agreement is entered into between Connecticut Vintage Equestrians, the Dunbars, their family, their volunteers, show vendors, and myself, as a visitor, rider, and/or owner of any horse while I am on the Dunbar's premises.

I acknowledge and agree as follows:

- Horses and horse activities are unpredictable and I realize that there are certain dangers inherent in equestrian activities including risks of property, damage, injury and death. I agree that as complete as the care and attention may be, as thoroughly planned as the activity may be, as well trained as a horse may be, that horses are prone to extreme reactions without warning. These actions as well as the actions of other animals cannot be controlled, and that the safety of myself, my horse, my property cannot be guaranteed while I am on the property. Knowing these risks, I voluntarily choose to participate and utilize the premises.
- Knowing the risks associated with my presence, I
 expressly assume the associated risks of injury,
 damage and death or loss of property as well as any
 financial loss, whether caused by the risks associated
 with horse activities, the actions of the property
 owners, their volunteers, or their family or any other
 cause.
- I assume the risk of any damage or injury caused by my horses and promise to indemnify the released parties against any and all claims for damage to persons or property caused by my horse, whether or not the horse is under my control at the time.
- I acknowledge that I am responsible for the security of my property and that the property owners cannot guarantee the security of my horse or property. All properties left on the premises are at my own risk.
- 5. On behalf of myself and my heirs, successors, guardians, legal representatives and assigns, I release and forever discharge the released parties, jointly and individually, from any and all claims, actions, demands, rights, causes of action and claims, based upon any bodily injury or disability, illness, death, financial loss, property loss, damage destruction or other harm of whatever nature, whether foreseen or unforeseen, that may be sustained or suffered by e or by any other person as a direct or indirect consequence of my presence and participation in any activity on the property owned by the Dunbars.

- 6. I hereby agree that I, my heirs, successors, guardians, legal representatives and assigns will not bring a claim against, sue, demand compensation from or attach the property or assets of the released parties for any loss or damage arising or resulting directly or indirectly from participation in equestrian activities or my presence at the property owned by the Dunbars.
- 7. I agree to indemnify, defend and hold harmless each of the released parties from and against any and all claims, suits, demands, liabilities, damages, losses, costs and expenses, including but not limited to damage to or destruction of property, compensatory, consequential or punitive damages, attorney's fees and other costs of defense arising from or in connection with the injury, illness or death of any person or the damage, destruction or loss of any of my or others' property which might result, directly or indirectly, from my participation in equestrian activities or from any horses owned by me or in my control.
- I agree that my participation in activities sponsored by CVE, Inc., and/or the Dunbars constitutes a release to photograph and/or video and publish and/or broadcast my involvement in such activity.
- The terms of this Agreement shall be governed by and interpreted according to the laws of the State of Connecticut or, the courts of which shall have exclusive jurisdiction over any matter arising hereunder. I understand that Title 52. Chapter 926. Section 52-557p of the Connecticut General Statutes provides that: "Each person engaged in recreational equestrian activities shall assume the risk and legal responsibility of any injury to his person or property arising out of the hazards inherent in equestrian sports, unless the injury was proximately caused by the negligence of the person providing the horse or horses to the individual engaged in recreational equestrian activities or the failure to guard or warn against a dangerous condition use, structure or activity by the person providing the horse or horses or his agents or employees. I FURTHER UNDERSTAND THAT THE TERMS OF THIS EXPRESS ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT GO BEYOND THE TERMS OF THIS STATUE TO INCLUDE THE WAIVER OF CLAIMS FOR ORDINARY NEGLIGENCE AND MEANS THAT I AM WAIVING CERTAIN IMPORTANT RIGHTS THAT I MIGHT OTHERWISE HAVE UNDER CONNECTICUT LAW.



- 10. I agree that this agreement is intended to be as broad and inclusive as is permitted by State law. If any portion of this agreement is determined to be invalid, illegal or unenforceable, that portion shall be severable and the validity, legality and enforceability of the balance of the agreement shall not be affected or impaired in any way and shall continue in full force and effect.
- 11. I agree to reimburse the released parties for any and all attorneys' fees incurred in enforcing the terms of this agreement.

- ~ I understand by signing this, I am giving up certain legal rights including the right to recover damages in case of injury death or property damage. I understand that this document is a promise not to sue and a release of and indemnification for all claims.
- ~ I have read this agreement carefully, and I fully understand all of its terms and conditions. My signature below is my acknowledgement that I have had an opportunity to carefully read the entire agreement and to have any questions answered to my satisfaction.
